



The A–Z of Activities is designed to provide Guiders with a tool to assist in common activity planning and determination of activity level. This document does not replace Safe Guide. Safe Guide should always be reviewed during your activity planning process.

Considerations for all Activities

It is important to ensure Guiders are still using the Activity Level Planning Chart prior to making a determination on the activity level. There are a number of factors that may change the activity level that may not be captured below. For example, distance from EMS, or youth unaccompanied for a portion of the activity may change the level of an activity.

Prior to all activities, Guiders should inform caregiver(s), as well as their Commissioner or ACL. An SG.4 should be completed for all activities, and shared with all supervisors, prior to the event.
