Re: Release and waiver of liability from Center Vorlage Inc. for the alpine ski center

To whom it may concern,

I, _____, hereby acknowledge and agree to the terms and conditions outlined in this Centre Vorlage Inc. Release and waiver of liability from Center Vorlage Inc. for the alpine ski center (hereinafter referred to as "Discharge") in consideration of being allowed to participate in activities at Centre Vorlage Inc.(hereinafter referred to as "Center")

1. Authorized activities at the Centre: Ski, snowboarding, Skimo, Snowshoeing, Fatbike

2. Assumption of Risk:

- a. I understand and acknowledge that snow sports are inherently dangerous activities and involve certain risks, including but not limited to, injury, disability, or death. I am fully aware of and voluntarily assume all such risks associated with these sports, including, but not limited to:
 - i. Collision or contact with other riders, objects, or natural features;
 - ii. Falling or losing control;
 - iii. Mechanical failure of equipment;
 - iv. Hazardous weather conditions;
 - v. Variation or difficulty of terrain

3. Release and Waiver of Liability:

- a. In consideration of being permitted to use the Centre and engage in snow sports mountain activities, I, on behalf of myself, my heirs, executors, administrators, and assigns, hereby release, discharge, and waive any and all claims, actions, causes of action, demands, liabilities, or damages of any kind, whether in law or equity, that I may have against Centre Vorlage Inc., its owners, officers, directors, employees, agents, contractors, and representatives (collectively referred to as "Released Parties"), arising out of or in connection with my use of the Park facilities, including but not limited to any injuries, disabilities, or death resulting from such use, except for any gross negligence or willful misconduct on the part of the Released Parties.

4. Indemnification:

- a. I agree to defend, indemnify, and hold harmless the Released Parties from and against any and all claims, liabilities, damages, losses, costs, or expenses (including reasonable attorneys' fees) arising out of or in connection with my use of the Centre facilities or any breach of this Waiver.

5. Medical Treatment:

- a. I authorize the Centre staff and its authorized agents to secure, at my expense, any medical treatment or attention they deem necessary for me in the event of an injury, accident, or illness while on the premises of the Centre.

6. Severability:

- a. If any provision or part of this Waiver is found to be invalid, illegal, or unenforceable, the validity, legality, and enforceability of the remaining provisions shall not in any way be affected or impaired.

7. Code of conduct:

- a. Know the code. Be safety conscious. It is your responsibility!

8. Governing Law and Jurisdiction:

- a. This Waiver shall be governed by and construed in accordance with the laws of Quebec without regard to its conflict of laws principles. Any legal action or proceeding arising out of or relating to this Waiver shall be exclusively brought in the courts located in Québec.
